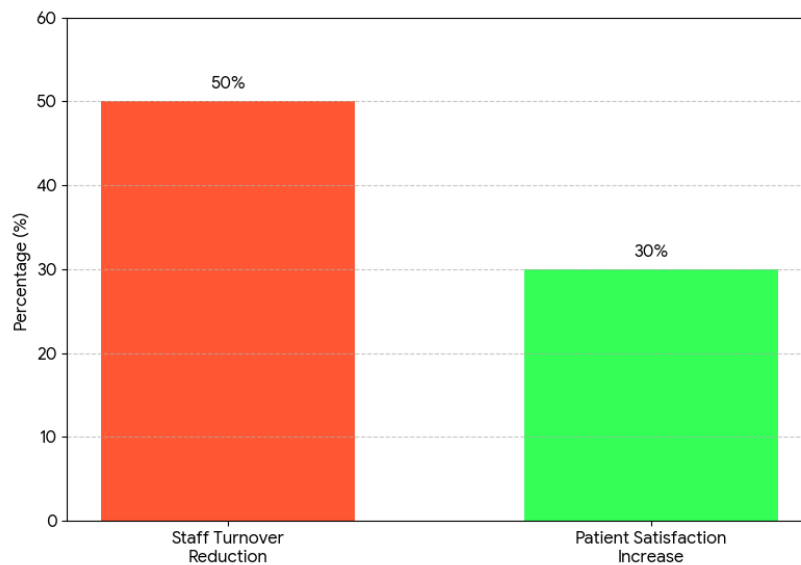

**Figure 1.** Impact of Adaptive Leadership in Healthcare

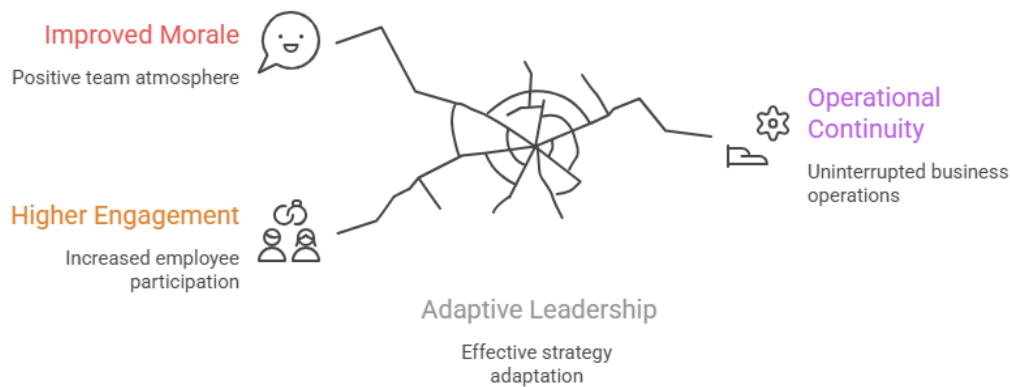
